Are costly bank fees, charged each time you deposit a sterling cheque, eroding the value of your dividends?

Do you face frustrating delays while waiting for your sterling dividend cheque to clear before your bank gives you access to your funds?

You now have an alternative - convenient and speedy access to your dividends paid in your local currency.

How does the service work?

Capita Registrars has partnered with Travelex, the world's largest specialist provider of commercial international payment services, to provide you with a service that will convert your Sterling dividends into your local currency at a competitive fee.

We will then arrange for these funds to be deposited directly into your local bank account – potentially saving you time and money.

Who is eligible?

The International Payment Service is available to private shareholders who receive individual dividend payments of £25 or more. Please see overleaf for the list of countries where this service is offered.

Benefits of the International Payment Service

- **Reduced fees** – for most overseas shareholders, the International Payment Service will generally cost less than the fees charged by your local bank to convert your sterling dividend cheque into local currency.*
- **Faster access to funds** – your dividends are paid as cleared funds, directly to your local bank account, allowing you to access your money faster than if you had to wait for your bank to clear your sterling dividend cheque.
- **Favourable exchange rates** – Capita Registrars, working in partnership with Travelex, will arrange for your dividend to be exchanged into your local currency at competitive rates based on actual market rates. These will generally be preferable to 'tourist' rates offered by banks to deposit overseas cheques.
- **Reduced risk of non-delivery or fraud** - the funds are sent directly to your bank account reducing the risk of non-delivery or fraud in respect of cheques.

How do I apply?

To apply for the service, simply complete and return the International Payment Service application form or alternatively, you can visit www.capitaregistrars.com/international and fill in the quick and easy online application form.

Please note that a separate application form is required for each shareholding and each company.

**Fees will differ amongst banks. You should compare the fees charged by your local bank before registering for the International Payment Service. Your normal account conditions will apply.*
